#### 3 Nature of the motion

The motion is a constitutional challenge to:

- Section 20(1) of the Births and Deaths Registration Act 51 of 1992,
   and
- Regulation 1 of the Regulations Relating to the Management of Human Remains in terms of the National Health Act 61 of 2003.

#### 4 Issues to be determined

- 4.1 Should be reaved parents who suffer pregnancy loss have a legal right to elect to bury the fetal remains? (The 'burial right'.)
- 4.2 Should persons who suffer pregnancy loss by means of a termination of pregnancy in terms of the Choice of Termination of Pregnancy Act 92 of 1996 also have the right to bury the fetal remains if they so wish?

#### 5 Relief sought

- 5.1 The first applicant seeks the relief as set out in its notice of motion. This includes (a) a declaratory order recognising the burial right, (b) an order declaring the impugned provisions unconstitutional, and (c) various interim and final measures to ensure that persons will be able to exercise the burial right. A draft order is attached hereto.
- 5.2 The second applicant (intervenor) supports the relief sought by the applicant, and seeks in addition orders declaring the impugned provisions inconsistent with the right to equality and the right to freedom of religion insofar as they prevent parents who on account of their religious or non-religious convictions from burying their deceased unborn children.
- 5.3 The respondents seek the dismissal of the application.
- 5.4 The first amicus curiae supports the relief sought by the applicants, subject to any revisions the Court finds are necessary to protect a woman's rights under the Choice of Termination of Pregnancy Act 92 of 1996.
- 5.5 The second and third amici curiae seek the dismissal of the application.
